Game Official Assignments – Long-List WM and WMIA

In respect of the performance of the Game Officials on the long list during the actual season 2019/2020, the final selection of the Game Officials will be done by the IIHF Officiating Committee.

The selected Game Officials for the following events will be announced in March 2020:

- 2020 IIHF WM, Zurich and Lausanne, Switzerland, 08.05. – 24.05.2020
(Arrival for WM preparation camp will be 04.05.2020)
- 2020 IIHF WMIA, Ljubljana, Slovenia, 27.04. – 03.05.2020

Confirmation Game Officials

Each Member National Association is responsible to discuss the approved nominations in order to receive the confirmation of participation of their Game Officials.

Therefore, we ask you kindly discuss each assignment with the assigned Game Official and provide us with a summary of availability by **October 11, 2019** to the IIHF Office (kurmann@iihf.com).

Once accepted by the MNA and the Game Official, the IIHF Office, without additional confirmation, will start the necessary travel arrangements and distribute the flight e-tickets to the Game Officials through the respective MNA Referee-in-Chief by email. The latter will be the case approximately one month before departure day.

Travel Arrangements

To simplify the process concerning travel arrangements for the IIHF Game Officials, we kindly ask you to discuss with each Game Official the following concerning their travel arrangements:

- **Closest Airport**, which is the closest airport from the Game Officials' domicile, or
- **Request** for travelling by car, or other ground transportation, to the assigned venue
- **Request** of special travel routes or dates (for example due to other assignments)

The IIHF Office will verify the requests in accordance with the IIHF Financial Regulations.

This **additional information** must be provided to the IIHF Office together with the summary of availability.

Please be informed that once the tickets have been booked the travel cannot be changed anymore, the issued tickets are not refundable. In the event of a forced change by your Member National Association any extra costs for re-routings must be covered by your National Association. The IIHF Office will send all arrival and departure information to the IIHF Championship Organizers in advance of the beginning of each Championship.
